

# **“Route 66 Fuel Sweepstakes (“The Big Fill”) (Yesway/Allsup’s)” Official Rules**

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES ENTRY PERIOD, YOU AGREE TO THESE OFFICIAL RULES, SO READ THEM CAREFULLY BEFORE ENTERING. THESE OFFICIAL RULES CONTAIN PROVISIONS THAT LIMIT OUR LIABILITY TO YOU, ELIMINATE YOUR RIGHT TO A TRIAL BY JURY, AND REQUIRE YOU TO RESOLVE DISPUTES WITH US ON AN INDIVIDUAL BASIS, AND NOT AS A PART OF ANY CLASS OR REPRESENTATIVE ACTION, AND THROUGH FINAL AND BINDING ARBITRATION. SEE BELOW.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID OUTSIDE THE STATES OF MISSOURI, NEBRASKA, NEW MEXICO, OKLAHOMA, SOUTH DAKOTA, TEXAS, AND WYOMING, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

## **1. ACCEPTANCE OF OFFICIAL RULES**

By participating in the 2026 Yesway “Route 66 Fuel Sweepstakes (Yesway/Allsup’s)” (the “Sweepstakes”), you hereby accept and agree to these official rules (the “Official Rules”) and the decisions of BW Gas & Convenience Retail, LLC d/b/a Yesway (“Yesway” or the “Administrator”), which decisions are final.

## **2. ELIGIBILITY**

The Sweepstakes is open to persons who are (1) legal residents of the states of Missouri, Nebraska, New Mexico, Oklahoma, South Dakota, Texas, and Wyoming, and (2) are eighteen (18) years of age or the age of majority in such state of residence, whichever is older at the time of entry. ## **3. ENTRY PERIOD**

The Sweepstakes begins at 12:00:00 a.m. Central Time on [3/4/2026] and continues to 11:59:59 p.m. on [3/5/2026] (the “Entry Period”). “Central Time” means either Central Standard Time or Central Daylight Savings Time depending on which time is in effect on the date in question. The Administrator is the official time keeper.

#### 4. HOW TO ENTER

There are four (4) methods of Sweepstakes entry:

- **Entry by Purchase:** Purchase any two (2) or more Oreo® King Size or Mountain DEW®/MUG® 20oz products from a participating Yesway® or Allsup's® location in a single transaction during the Entry Period and enter your phone number associated with your Yesway & Allsup's Rewards account at checkout when making your qualifying purchase. You will only receive one (1) Sweepstakes entry regardless of the number of Oreo® King Size or Mountain DEW®/MUG® 20oz products purchased in excess of two in a single transaction and per valid receipt. Registration for Yesway & Allsup's Rewards is free online at <https://yeswayallsuprewards.com/> or in the Yesway & Allsup's Rewards app (the "App"), which can be downloaded for free through the Apple App Store or Google Play.

- **Mail-In (No Purchase):** To submit an entry by mail, you must hand print your first and last name, residence address, telephone number associated with your Yesway & Allsup's Rewards account (if applicable), e-mail address, and date of birth on a 3"x5" card; place the card in an envelope with proper first-class postage affixed; and mail to: Route 66 Fuel Sweepstakes (Yesway/Allsup's), c/o Yesway Marketing, 2301 Eagle Parkway, Suite 100, Fort Worth, Texas 76177. Mailed entries must be postmarked during the Entry Period and received by [7/4/2026]. There is a limit of one (1) 3"x5" card per stamped, outer envelope. Each properly submitted mail-in entry equals one (1) entry.

- **Online Entry (No Purchase):** During the Entry Period, scan the QR code found on participating signage, packaging, or promotional materials or visit [yesway.com/sweepstakes](https://yesway.com/sweepstakes). You will be directed to an entry page where you must complete and submit the required information (e.g., name, email, phone number). There is a limit of one (1) entry per person per day via online entry. For purposes of this Sweepstakes, a "day" is the 24-hour period from 12:00:00 a.m. to 11:59:59 Central Time.

- **Smiles Redemption Entry (No Purchase):** Yesway & Allsup's Rewards members may redeem two hundred fifty (250) Smiles in the App to receive one (1) Sweepstakes entry. For every additional 250 Smiles redeemed in a single or separate redemption, you will receive one (1) additional entry (e.g., 500 Smiles = 2 entries; 750 Smiles = 3 entries). Smiles redemptions are processed instantly, will be deducted from the member's account, and are final and non-refundable. Smiles have no cash value and cannot be combined with other offers or reinstated for any reason (including if the Sweepstakes is canceled or if an entry is voided). Account must be active and in good standing at time of redemption. The daily limit in the QR Code subsection does not apply to Smiles Redemption Entries; entries via Smiles are awarded per full 250-Smiles increment redeemed.

Illegible and/or incomplete entries and entries submitted by an Entrant who does not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Normal time rates, if any, charged by the your Internet service or mobile provider will apply.

## **5. PRIZES**

Grand Prize: One (1) Grand Prize is available. The "Grand Prize" is: one (1) Two Thousand Five Hundred Dollar (\$2,500) Yesway/Allsup's gift card. Approximate Retail Value ("ARV") of each Grand Prize is \$2,500 USD.

First Prize: Forty eight (48) First Prizes are available. Each "First Prize" is: one (1) Sixty-six dollar (\$66) Yesway/Allsup's gift card. ARV of each First Prize is \$66 USD.

The \$2,500 Fuel Gift Card value is based on an estimated 16 gallons of fuel purchased once per week for 52 consecutive weeks; actual usage and duration may vary by winner.

## **6. WINNER SELECTION AND NOTIFICATION**

Within thirty (30) days of the expiration of the Entry Period, the potential "Winners" will be determined via a random drawing from all Eligible Entries received, provided this time line is subject to change in Yesway's sole discretion. If a potential Winner cannot be reached after a reasonable effort has been exerted or fails to respond within three (3) days of notification, or if a prize or prize notification is returned as undeliverable, the potential Winner forfeits the prize, and an alternate potential Winner will be randomly drawn from all remaining Eligible Entries. If the

alternate potential Winner similarly cannot be reached, fails to respond, or forfeits the prize, the prize is forfeited and another alternate potential Winner will be randomly drawn from all remaining Eligible Entries. This process shall continue until a Winner is confirmed for each prize.

The approximate retail value of each prize represents Yesway's good-faith determination of the approximate retail value of the prize, is final and binding and cannot be challenged or appealed. If the stated approximate retail value of each prize is more than the actual fair market value of the prize, the difference will not be awarded. The ARV is subject to change based upon current market conditions at the time of prize fulfillment. Any difference between ARV and actual value will not be awarded. Limit one (1) prize per person. If, for any reason, the Sweepstakes is not capable of running

If the Sweepstakes or any part of it is terminated or modified prior to the end of the Entry Period, notice will be posted on [yesway.com/sweepstakes](https://yesway.com/sweepstakes) if time permits, and the prizes will be awarded in a random drawing from among all remaining uncorrupted Eligible Entries received prior to such event. Yesway reserves the right to modify, withdraw, replace, or amend these Official Rules, including the Entry Period and/or the manner, timing and number of drawings.

The Sweepstakes Entities will not be responsible or liable for failure to receive entries due to any act, failure to act, delay, or error relating to the transmitting or processing of entries, or technical failures of any kind. ## **13. DISPUTES**

THIS SWEEPSTAKES AND THESE OFFICIAL RULES WILL BE GOVERNED BY THE LAWS OF THE STATE OF TEXAS. IF NOT RESOLVED THROUGH DIRECT

DISCUSSIONS, ANY DISPUTE OR CLAIM SHALL BE RESOLVED BY FINAL BINDING ARBITRATION WITH AN EXPERIENCED ARBITRATOR LICENSED TO PRACTICE LAW IN TEXAS. THE VENUE FOR ANY PROCEEDINGS SHALL BE IN TARRANT COUNTY, TEXAS. REMEDIES SHALL BE SUBJECT TO ALL LIMITATIONS AND RELEASES IN THESE OFFICIAL RULES, BE LIMITED TO ACTUAL OUT OF POCKET DAMAGES, AND SHALL NOT, IN ANY EVENT, INCLUDE ANY PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, ATTORNEY'S FEES OR OTHER COSTS, OR INJUNCTIVE OR OTHER EQUITABLE RELIEF.
