

YESWAY & ALLSUP'S 2026 ROUTE 66 TRUCK SWEEPSTAKES OFFICIAL RULES

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES ENTRY PERIOD, YOU AGREE TO THESE OFFICIAL RULES, SO READ THEM CAREFULLY BEFORE ENTERING. 1. **ACCEPTANCE OF OFFICIAL RULES**: By participating in the "Yesway & Allsup's 2026 Route 66 Truck Sweepstakes" (the "Sweepstakes"), you hereby accept and agree to these official rules (the "Official Rules") and the decisions of BW Gas & Convenience Retail, LLC d/b/a Yesway ("Yesway") or the "Sponsor"), which decisions are final and binding.

2. **ELIGIBILITY**: The Sweepstakes is open to persons who (1) are legal residents of Arizona, Missouri, Nebraska, New Mexico, Oklahoma, South Dakota, Texas, or Wyoming, and (2) are at least eighteen (18) years of age or the age of majority in their state of residence, whichever is older, at the time of entry. Employees, officers, and representatives, and members of their immediate families (i.e., parents, spouses, siblings, children, grandparents, stepparents, stepchildren, and stepsiblings, and their respective spouses, and those living in the same household, whether or not related) of the Sponsor and its affiliated companies, parent companies, subsidiaries, participating promotional partners, distributors, advertising and promotion agencies, and any company involved in the creation, design, execution, production, or fulfillment of the Sweepstakes (collectively, the "Sweepstakes Entities") are not eligible. All entries submitted in compliance with these Official Rules and not disqualified or void are considered "Eligible Entries".

3. **ENTRY PERIOD**: The Sweepstakes begins at 12:00:00 a.m. CT on July 1, 2026 and ends at 11:59:59 p.m. CT on January 5, 2027 (the "Entry Period"). "CT" means either Central Standard Time or Central Daylight Savings Time depending on which is in effect on the date in question. The Sponsor is the official timekeeper.

4. **HOW TO ENTER**: There are five (5) methods of Sweepstakes entry:

- **In-Store Entry (Qualifying Purchase)**: Purchase any two (2) or more participating promotional products from a participating Yesway® or Allsup's® location in a single transaction during the Entry Period and enter the phone number associated with your Yesway & Allsup's Rewards account at checkout when making your qualifying purchase. "Participating promotional products"

means products designated by Sponsor in in-store signage, the Yesway & Allsup's Rewards app (the "App"), point-of-sale materials, or other promotional materials for this Sweepstakes. You will receive only one (1) Sweepstakes entry per qualifying transaction and with a valid receipt, regardless of the number of qualifying products in excess of two (2) purchased in a single transaction.

Registration for Yesway & Allsup's Rewards is free online at [yeswayallsuprewards.com](https://www.yeswayallsuprewards.com) or in the App, which can be downloaded for free through the Apple App Store or Google Play.

- **Mail-In Entry (No Purchase)**: To submit an entry by mail, hand print your first and last name, date of birth, residence address, telephone number associated with your Yesway & Allsup's Rewards account (if applicable), and email address on a 3" x 5" card; place the card in an envelope with proper first-class postage affixed; and mail it to:

Mailed entries must be postmarked during the Entry Period and received by January 8, 2027. There is a limit of one (1) 3" x 5" card per stamped outer envelope. Each properly submitted mail-in entry equals one (1) Sweepstakes entry.

- **Online Entry (No Purchase)**: During the Entry Period, either scan the QR code found on participating signage, packaging, or promotional materials, or visit [yesway.com/sweepstakes](https://www.yesway.com/sweepstakes). You will be directed to an entry page where you must complete and submit the required information (e.g., name, e-mail address, and phone number). There is a limit of one (1) entry per person per day via online entry. For purposes of this Sweepstakes, a "day" is the 24-hour period from 12:00:00 a.m. to 11:59:59 p.m. CT.
- **Smiles Redemption Entry (No Purchase)**: Yesway & Allsup's Rewards members may redeem two hundred fifty (250) Smiles in the App to receive one (1) Sweepstakes entry. For every additional 250 Smiles redeemed in a single or separate redemption, you will receive one (1) additional Sweepstakes entry (for example, 500 Smiles = 2 entries; 750 Smiles = 3 entries). Smiles redemptions are processed instantly, are deducted from the member's account, and are final and non-refundable. Smiles have no cash value and cannot be combined with other offers or reinstated for any reason, including if the Sweepstakes is canceled or if an entry is voided. The member's account must be active and in good standing at the time of redemption. This entry method is subject to all eligibility requirements, limits, procedures, and other terms stated in the Summer Sweepstakes official rules.

Except as expressly set forth under the Online Entry method above, there is no limit on the number of Eligible Entries you may submit during the Entry Period, regardless of entry method. The odds of winning depend on the total number of Eligible Entries received during the Entry Period.

5. PRIZES:

Grand Prize: One (1) Grand Prize is available. The "**Grand Prize**" is: one (1) Ford F-150 truck with an approximate retail value ("**ARV**") of sixty thousand dollars (\$60,000 USD), plus five thousand dollars (\$5,000 USD) intended to help offset tax, title, license, and registration fees associated with the vehicle (the "**TTL Allowance**"). The total ARV of the Grand Prize is sixty-five thousand dollars (\$65,000 USD). The Grand Prize vehicle may be new, may have been used for promotional purposes, and may have an odometer reading of not more than two thousand five hundred (2,500) promotional miles at the time of delivery.

Grand Prize vehicle details, including model year, trim, color, optional equipment, and dealership or delivery location, will be determined by Yesway in its sole discretion, subject to availability. The TTL Allowance is provided as a convenience only and may not cover all costs required to title, license, register, and insure the vehicle. Winner is solely responsible for any and all costs not expressly provided in these Official Rules, including, but not limited to, any amount of taxes, title, license, registration, documentation, dealer fees, insurance, fuel, maintenance, additional accessories, and any other costs of ownership or use. If the TTL Allowance exceeds the actual eligible fees incurred, such excess shall not be awarded or payable.

6. WINNER SELECTION AND NOTIFICATION: On or about January 29, 2027, Sponsor (or its designee) will conduct a random drawing from all Eligible Entries received during the Entry Period, including eligible Truck Entries awarded through the Summer Sweepstakes entry method, to select one (1)

potential Grand Prize Winner, provided this timeline is subject to change in Yesway's sole discretion. Odds of winning the Grand Prize depend on the total number of Eligible Entries received.

The potential Winner will be notified using the email address, phone number, or other contact information associated with the winning entry or, as applicable, the Yesway & Allsup's Rewards account tied to the winning entry. If the potential Winner cannot be reached after reasonable efforts, fails to respond within five (5) business days of notification, or if a prize or prize notification is returned as undeliverable, the potential Winner forfeits the prize and an alternate potential Winner will be randomly drawn from the remaining Eligible Entries. This process will continue until a Winner is confirmed for the Grand Prize.

Limit one (1) Grand Prize. No cash alternative, assignment, or substitution of a prize is permitted, except at Yesway's sole discretion. Yesway reserves the right to substitute a prize, or any portion of a prize, of comparable or greater value if a prize, or any portion of a prize, is unavailable. The value of any prize won may be taxable to the Winner as income. An IRS Form 1099 may be issued in the name of the Winner for the actual value of the prize awarded. REMEDIES WILL BE SUBJECT TO ALL LIMITATIONS AND RELEASES IN THESE OFFICIAL RULES, BE LIMITED TO ACTUAL OUT-OF-POCKET DAMAGES, AND WILL NOT, IN ANY EVENT, INCLUDE ANY PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, ATTORNEYS' FEES OR OTHER COSTS, OR INJUNCTIVE OR OTHER EQUITABLE RELIEF.
