

## YESWAY & ALLSUP'S 2026 SUMMER SWEEPSTAKES DIGITAL GAME OFFICIAL RULES

BY SUBMITTING AN ENTRY TO THIS GAME DURING THE GAME PERIOD, YOU AGREE TO THESE OFFICIAL RULES, SO READ THEM CAREFULLY BEFORE ENTERING. **1. ACCEPTANCE OF OFFICIAL RULES:** By participating in the "Yesway & Allsup's 2026 Summer Sweepstakes Digital Game" (the "Game"), you hereby accept and agree to these official rules (the "Official Rules") and the decisions of BW Gas & Convenience Retail, LLC d/b/a Yesway ("Yesway" or "Sponsor"), which decisions are final and binding.

**2. ELIGIBILITY:** The Game is open to persons who (1) are legal residents of Arizona, Missouri, Nebraska, New Mexico, Oklahoma, South Dakota, Texas, or Wyoming, and (2) are at least eighteen (18) years of age or the age of majority in such state of residence, whichever is older, at the time of entry. Employees, officers and representatives and members of the immediate families (i.e., parents, spouses, siblings, children, grandparents, stepparents, stepchildren and stepsiblings, and their respective spouses, and those living in the same household, whether or not related) of the Sponsor, and its affiliated companies, parent companies, subsidiaries, participating promotional partners, distributors, advertising and promotion agencies, and any company involved in the creation, design, execution, production, or fulfillment of the Game are not eligible. All entries submitted in compliance with these Official Rules and not disqualified or void are considered eligible. Enrollment in Yesway & Allsup's Rewards is free.

**3. GAME PERIOD:** The Game begins at 12:00:00 a.m. CT on July 1, 2026 and ends at 11:59:59 p.m. CT on September 8, 2026, or immediately upon award of all Spins, whichever comes first (the "Game Period"). "CT" means either Central Standard Time or Central Daylight Savings Time depending on which is in effect on the date in question. The Sponsor is the official timekeeper.

**4. HOW TO PARTICIPATE:** The Game utilizes Digital Spin to Win opportunities (each, a "Spin") that can be played on a computer, tablet or smartphone. Five hundred eighty thousand fifty (580,050) Spins will be available. Every Spin reveals your Yesway & Allsup's Rewards prize. You earn Spins during the Game Period in either of the following ways:

- **In-Store Entry (Qualifying Purchase):** Purchase a participating product at a participating Yesway® or Allsup’s® location and enter your Yesway & Allsup’s Rewards phone number at checkout to earn a Spin. For a list of participating products, see Table 1 below. Spins are delivered to the Yesway & Allsup’s Rewards account tied to the phone number used at checkout.

- **Mail-In Spin Request (No Purchase):** To request a Spin by mail, hand print your first and last name, date of birth, residence address, telephone number associated with your Yesway & Allsup’s Rewards account, and e-mail address on a 3” x 5” card; place the card in an envelope with proper first-class postage affixed; and mail it to:

Mailed Spin requests must be postmarked and received during the Game Period. There is a limit of one (1) 3” x 5” card per stamped outer envelope. Each properly submitted mail-in Spin request equals one (1) Spin.

You will receive an email or text message notifying you that your Spins are available. Follow the instructions to complete your Spins and reveal your game messages. Spins are limited to a maximum of thirty (30) per day, per account. **All Spins must be used by the end of the Game Period.**

**5. PRIZES:** Spin outcomes are shown in Table 2. Product and reward prizes have approximate retail values (“ARVs”) ranging from \$0.10 to \$89.75 each, excluding reward prizes consisting of entries into the Secondary Sweepstakes described below. Product and reward prizes are subject to availability. The value of any redeemed cents per gallon (“CPG”) savings will vary with the amount of fuel purchased. CPG savings prizes are each limited to a maximum of 30 gallons of fuel. When a product prize awards multiple units of the same product, each unit is awarded as a separate prize (for example, a prize of 25 Free Pepsi 20oz will be fulfilled as 25 individual Pepsi 20oz prizes). Prize messages may not be reproduced and may not be combined with any other coupons or promotional offers, except as set forth herein with respect to CPG savings. **CPG savings prizes must be redeemed within thirty (30) days after the date the prize is**

awarded. Product prizes consisting of twenty-five (25) units must be redeemed at any participating location by the close of business at that location on December 31, 2026. All other product prizes must be redeemed at any participating location by the close of business at that location on September 11, 2026. Not all prizes may be claimed or redeemed.

The Yesway & Allsup's 2026 Route 66 Truck Sweepstakes runs from 12:00:00 a.m. CT on July 1, 2026 through 11:59:59 p.m. CT on January 5, 2027. The Big Fill runs from 12:00:00 a.m. CT on July 1, 2026 through 11:59:59 p.m. CT on September 8, 2026. Reward prizes of entries into the Secondary Sweepstakes do not guarantee that a participant will win any prize in the Secondary Sweepstakes. Odds of winning any prize in the Secondary Sweepstakes depend on the total number of eligible entries received for that promotion. CPG savings prizes will be automatically loaded onto the winner's Yesway & Allsup's Rewards account, and the winner may take the discount available on a future fuel purchase. Multiple CPG savings prizes can be applied to the same fuel purchase.

**7. SELECTION OF WINNERS:** Prize options resulting from Spins will be awarded on a rolling basis throughout the Game Period according to the availability of prizes and the odds set forth in Table 2 above.

**8. ODDS TO WIN:** The overall odds of winning a prize option are 1 in 1. The individual odds to receive any specific prize option are detailed in Table 2 above.

THE VENUE FOR ANY PROCEEDINGS SHALL BE IN TARRANT COUNTY, TEXAS. REMEDIES SHALL BE SUBJECT TO ALL LIMITATIONS AND RELEASES IN THESE OFFICIAL RULES, BE LIMITED TO ACTUAL OUT OF POCKET DAMAGES, AND SHALL NOT, IN ANY EVENT, INCLUDE ANY PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, ATTORNEY’S FEES OR OTHER COSTS, OR INJUNCTIVE OR OTHER EQUITABLE RELIEF.
