

2026 YESWAY and ALLSUP's Spin-to-Win Game & Sweepstakes Official Rules

1. **Eligibility/Participation:** The 2026 YESWAY and ALLSUP's Spin-to-Win Game & Sweepstakes (the "Game" or "Sweepstakes") is open only to legal residents of the U.S. in one of the following States: Arizona, Missouri, Nebraska, New Mexico, Oklahoma, South Dakota, Texas, or Wyoming ("Eligibility Area") who are twenty-one (21) years of age or older as of September 9, 2026. Employees, directors and officers of BW Gas & Convenience Retail, LLC d/b/a Yesway ("Sponsor" or "Game Administrator"), Dr Pepper/Seven Up, Inc. ("Prize Partner"), Amp Agency c/o Upshot LLC ("Sweepstakes Administrator"), and any of their respective affiliates, parents, subsidiary companies, and advertising and promotion agencies (collectively, the "Released Parties"), and members of the immediate families (spouses, parents, stepparents, children, stepchildren, siblings, and stepsiblings, regardless of where they reside), and/or those living in the same household, of any of the foregoing, are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws. 2. **Sweepstakes Period:** The Sweepstakes begins at 12:00:00 am Central Time ("CT") on September 9, 2026 and ends at 11:59:59 pm CT on November 3, 2026 or immediately upon award of all Spin(s), whichever comes first (the "Sweepstakes Period"). The Game Administrator will keep the official clock for the Spin-to-Win Game.
3. **How To Play:** During the Sweepstakes Period, the Game utilizes Digital Spin to Win opportunities ("Spin(s)" or "Play(s)") that can be played on a computer, tablet or smartphone. Every Spin reveals your Yesway & Allsup's Rewards ("Rewards") prize, which include product(s), fuel rewards, or entry into a drawing for Sweepstakes Prizes. There is a limit of a maximum of thirty (30) Spins per day, per account. **All Spins must be taken by 11:59:59 PM CT on Tuesday, November 3rd.** There are three methods to enter the Spin to Win Game:
 - A. **In-Store Qualifying Purchase Entry:** During the Sweepstakes Period, enter your phone number when purchasing a Dr Pepper 20oz bottle or fountain drink at any Allsup's or Yesway Store ("Participating Locations") to earn your Spin. Opportunities to Spin are automatically delivered to the Rewards account for the authorized phone number provided at the time of your qualifying Rewards purchase. If you are not enrolled in Yesway & Allsup's Rewards, you can enroll at www.yeswayallsupsrewards.com or by downloading the mobile app at Google Play or the Apple App Store. Creation of an account on the App is free. Unclaimed prizes will not be awarded. For the avoidance of doubt, you have not "Played" the Game until you complete the required

entry information and reveal a winning or non-winning message. Any attempt by any entrant to obtain more than the stated number of Plays, by using multiple/different email addresses, identities, registrations, accounts, logins, or any other methods will void that entrant's Plays and that entrant may be disqualified. Use of any automated, programmed, robotic or similar system to participate is prohibited and may result in disqualification.

Mailed entries must be postmarked during the Entry Period (beginning September 9, 2026 at 12:00:00 a.m. CT and ending November 3, 2026 at 11:59:59 p.m. CT) and received by November 6, 2026. There is a limit of one (1) 3" x 5" card per stamped outer envelope. Each properly submitted mail-in entry equals one (1) Sweepstakes entry.

Please allow reasonable time for postal processing. Mail-in entries must be postmarked and received during the Sweepstakes Period to qualify. The Sponsor is not responsible for lost, late, damaged, misdirected, mutilated, illegible, incomplete, or postage-due mail-in entries.

For methods that award Spins, you will receive an email or text notifying that your Spin(s) are available. Follow the instructions to complete your Spin(s) and reveal your results.

- C. **Smiles Redemption Entry (No Purchase):** Yesway & Allsup's Rewards members may redeem two hundred fifty (250) Smiles in the App to receive one (1) Sweepstakes entry. For every additional 250 Smiles redeemed in a single or separate redemption, you will receive one (1) additional Sweepstakes entry (for example, 500 Smiles = 2 entries; 750 Smiles = 3 entries). Smiles redemptions are processed instantly, are deducted from the member's account, and are final and non-refundable. Smiles have no cash value and cannot be combined with other offers or reinstated for any reason, including if the Sweepstakes is canceled or if an entry is voided. The member's account must be active and in good standing at the time of redemption. The daily limit described in the Online Entry subsection does not apply to Smiles Redemption Entries; entries via Smiles are awarded per full 250-Smiles increment redeemed.

Instant Prizes will be automatically loaded onto the Rewards account allowing the bearer to redeem the prize at a Participating Location. Sponsor will verify such potential prize winners as official. In the event there are not enough eligible Game Plays in order to award all prizes, such prizes will remain un-awarded. Product prizes have approximate retail values ranging from \$2.09 to \$75.00. Not all product prize selections may be claimed or redeemed. TOTAL PRIZES: The total approximate retail values of all available prizes, including the Sweepstakes Prizes noted below, is three hundred fifty-eight thousand six hundred fifty dollars (ARV: \$358,650).

THE RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED IN PROMOTIONAL LAW AND LICENSED TO PRACTICE LAW IN TEXAS.
